What is the overall <u>deductible</u> ?	\$1,500 person \$3,000 family in-network provider. <u>Out-of-network providers</u> not covered.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , Office Visit, and <u>Urgent Care</u> services are covered before you meet your deductible.
